## **Pecan Grove Reflections From 2025**

- The Second Annual Pecan Grove Christmas Walk & Stroll was held
- Residents had "Fun in the Snow "in January by sledding and building snow men
- In February the refurbishing of our cluster mailboxes began as they are now POA responsibility
- The park benches throughout the neighborhood were repaired and painted
- The Bulletin Board at Windmill and Plantation was rebuilt.
- Pecan Grove's Annual Spring Community-wide Garage Sale was held once again
- Brick wall on Old South/Pecan Crossing fell and had to be repaired
- April brought the discovery of Bald Eagles Nests (April Newsletter).
   One in the woods by Firehouse 2 with others around the Harvest Green area and around Skinner Road
- The Entrance Landmark Sign at FM 359 was leveled because of shifting.
- The Fort Bend County Parks & Recreation opened the Sports Hub,
   727 Planation Drive. It is around 64,000 sq. ft. with 4 basketball courts and 8 volleyball courts.
- In place of the Easter Egg Hunt our Easter Rabbit (ROTC Cadet from Travis HS and his helper) rode through Pecan Grove on a PGVFD truck, threw candy which included small rabbits that could be exchanged for an Easter basket. Residents liked the community feel.
- Enumerate, a new Community Management software was introduced. It has helped to make autopay and Home Owner ACC requests easier because of shorter response time.
- The POA dedicated a picnic table and remembrance plaque for Jim Ashmore and Frank Jarett, long-time, past Board members. It was placed by the lake near the Memorial area for all to enjoy.
- Our Fourth of July fireworks display is growing as each year passes.
   This year was another huge success thanks to the funding of the CIA, HOA and POA and the tremendous work of the PGVFD.

- The Annual Pecan Grove Volunteer Fire Department's 5 Miles My Way was held and, once again, was a huge success.
- Summerland Drive lost some trees to termites and age. They were removed and five oak trees planted in their place.
- Plantation Road Repair was started and was extended 4-5 months due to the major traffic damage to the road but looks like a new road now
- Our landscaping contract with Yellowstone Landscape was renewed for another year
- The POA Elections were held in October. The declared winners were Guy Steiger, Steve Lutz and Kim Hollas who will continue in their current positions as President, Vice President, and Community Affairs.
- Deed Restrictions Thanks to the neighborhood's strong cooperation we were able to resolve 403 (92%) from a total of 438 resident property-related concerns such as: Lawns, Shrubbery, and Trees (29%), Trailers, RVs, and Boats (14%), Clutter (12%), Stored Vehicles (13%), Fences (8%), and Miscellaneous 24%
- Financial goal for the end of 2026 is a cash reserve of \$100,000.
   This will be to help with any unexpected expenditures associated with our neighborhood. Your Board will continue to look for opportunities to reduce expenses where possible as they have in the past.
- The Architectural Control Committee, in 2025, had the most modifications (166 requests) in 5 years. Thirty days is allowed for approval but our ACC members have tried to approve within 3 days. They have, in the last 4 years, maintained 96% completion in that timeline.

# Maintenance (Assessment) Fee for 2026 Increased

The Annual Maintenance Fee for 2026 has been voted on and has been increased 10% to \$275.00 for next year, 2026.

As part of the new 2026 budget, we will continue to work on maintaining our \$100,000 cash reserves for future unexpected expenses.

There has been an on-going discussion between the POA, County Commissioner and the USPS regarding cluster box maintenance. We replaced one box on Old South due to an auto accident this year. Moving forward we have decided that to ensure that our mail continues being delivered we are going to include a part of our budget each year to cluster box repairs and possible replacements at about \$2,000 per box.

NOTE: The annual Assessment is reviewed each year by the PGPOA Board and is subject to increases up to 10% with Board approval.



## **ENUMERATE::.**

Need to make an online payment of your 2025 Assessment (Maintenance Fee), submit a Homeowner Improvement Request (ACC Application), or just ask a question or voice a concern. The Pecan Grove POA encourages all residents to register, submit ACC Requests and make payments online.

This can all be completed via our new Enumerate site but you must register first.

To register, go here → Enumerate Login and select "Need to Register" When you first register you will be asked for the section, block and lot of your home, if you don't know it, just select "I can't find it" and continue. Your request will be sent for review to ensure you are a Pecan Grove Resident; this will normally be completed in a couple of hours but may take longer if submitted after hours. If you are already registered just input your UID and PW for access.

Once approved, you will receive a note to set your password and you are good to go. Please save your credentials for future use. As registration increases the POA Board will also be able to provide important information impacting Pecan Grove directly to residents.
