

Deed restrictions

Deed restrictions may be referred to covenants or restrictive covenants.

Because a deed restriction is essentially a contract – an agreement into which you freely enter by virtue of purchasing a property – these restrictions can cover a wide number of issues such as:

- How your property looks, what color you can paint your home, and in what condition you must maintain the exterior of your property
- Limitation of pets, livestock, or farm animals
- Rules about home-based businesses
- Rules governing room additions, and construction projects performed on your home

Deed restrictions are legal even if they severely constrain what you believe to be your rights to enjoy your property. But for reference purposes you may go to http://www.pecangrove.org , "Covenants" and put in your street address. You will be directed to your Section's deed restrictions.

Pecan Grove Plantation Tidbit

Bruce Belin and Associates purchased approximately 1,450 acres in 1973 and by 1978 began construction of the development. Named for the stately pecan trees growing in the area, the community was originally referred to as Pecan Grove Plantation and later simply Pecan Grove.

It is Richmond's first master-planned community, built around a beautiful 27-hole golf course.

The residents of Pecan Grove began the tradition of decorating for the holidays in the early 1990's and is now one of the most popular destinations for holiday lights in the Houston area.

Enchanting Texas, Explore the Lone Star State (travel blog) in its April 5, 2023 lists "Pecan Grove Christmas Lights, Ultimate Guide 2023. "Visit Pecan Grove neighborhood near Houston, Texas. The community is known for its impressive, over-the-top, and simply stunning Christmas displays."

Golf Carts

We have had some questions posed to us regarding rules regarding golf carts and their use in our community.

According to the Texas Transportation Code which regulates the operation of golf carts

- 502.001 "Golfcart" means motor vehicle designed for transporting persons on a golf course
- 521.021 License Required means a valid driver's license is required to operate a golf cart on a public roadway
- 521.458 Permitting Unauthorize Person to Drive
 - A. A person may NOT knowingly permit or cause a person's child or ward who is less that 18 years of age to operate a motor vehicle on a highway
 - B. A person may NOT authorize or knowingly permit a motor vehicle owned by or under the control of that person to be operated on a highway by any person in violation of this Chapter. Which means You cannot authorize your child to operate the golf cart on the roadway unless he has a Learner's Permit and you are with him OR he has a valid Driver's License.

Miscellaneous Points

- 1. Golf carts are not required to have a "slow vehicle" emblem unless they are operated on roads with a speed limit of 35 or higher
- 2. Lights, brake lights, turn signals, etc. are not required
- 3. Golf cars may not be operated on sidewalks
- 4. Golf carts may not be operated on trails or water retention areas owned by the MUD. This is a violation of the Texas Water Code which is a Class "C "Misdemeanor

As Steven has been working 14 hours a day since he was 20 and is looking forward to not working weekends

The Swinging Door, Steven and his staff will be missed.






Flags Across the Brazos

Thank you to Monte's and Enchanted Gardens for giving \$25 gift cards to each winner.




